- The end results of this project, i.e. of implementing the LAW AND GENDER master programme shall be to offer in-depth knowledge of reasons for gender mainstreaming in law, economics, politics and policies of the European Union and its member states and accession countries.

Textbook

- Textbook *Gender Sensitive Legal Education* will encompass 17 texts plus an introductory one, plus an article on the Gender Equality Legal Clinic. The nature of the publication imposes a rather extensive volume. Namely, the contents of all syllabi for all mandatory and optional courses for the Law and Gender master's programme will be covered by these chapters.
- It will amount to around 400 to 500 pages.
- The chapters will be scientific analyses of all legal fields of knowledge related to the positive civil, public, international, criminal law, European Union Law, as well as to the legal-economic, legal-historical, theoretical-legal fields of legal education.
- The traditional interpretation of the mentioned fields of legal education and knowledge production will be "deconstructed" and "constructed" again (metaphorically speaking), meaning that they will be reconsidered and rewritten from the gender sensitive point of view.
- Team work and deliberation on the particular topics in the framework of different educational and cultural background will be challenging and controversila, but productive.

LLLP

- The online LLL platform will enable full transparency, constant information availability, on-line empirical survey access, online evaluation of all events, especially of the multiplier events/conferences and the Publication. The LLL will enable using all relevant information on the Curriculum and the Legal Clinic. All syllabi and relevant texts, links, the textbook, empirical survey tool will be available online, on this platform.
- The LLL platform will also be used for informal learning on gender equality, for a constant and wide range dissemination and promotion of gender equality, and for presenting examples of gender inequality in any area of life, in all Consortium members and wider.
- It will also be used for compiling information on events, publications, conferences, etc. related to gender issues, as well as for connecting with all networks gathered around the gender issues.

Empirical Survey Tool

This will be the first questionnaire based on a systemic approach to all relevant dimensions for researching the quality of gender equality in academic institutions. It will mean a standardised new tool, applicable to all other faculties and universities.

Another innovation in this research will be the comparative approach to the results based on equal questions put to equally educated individuals in five culturally very different university environments.

The opinions of the same number of staff representatives of 5 universities will be focused on three dimensions regarding gender (in)equality: a) institutional framework (quality of rules and regulations regarding career promotion, gender pay gap, maternity leave and parental leave, family friendly institutional support, new jobs` announcements, protection from sexual harassment and mobbing, as well as from family violence), b) educational framework – quality of gender (in)sensitivity of the study programmes, syllabi and textbooks, as well as of the pedagogical approach and "the hidden curriculum" (value statements, prejudices, and stereotypes implied in the communication and relation between academic staff in itself and between professors and students); and c) cultural setting – value systems, stereotypes, prejudices of the professors regarding gender issues in academia

GELC

- The Gender Equality Legal Clinic which will be developed within the LAWGEM project will offer basic knowledge on gender equality, anti-discrimination, equal opportunities, issues of intersectional female subordination, essence of family violence and sexual harassment and the legal, institutional, and other interlinked modalities of combating it.
- Syllabus will be created by experts from Orebro U in the communication with other Consortium members.
- GELC will be the 5th obligatory course at Law and Gender master.
