LAWGEM IO No. 3 INSTRUCTIONS FOR THE TEXTBOOK PUBLICATON

Main information:

The Textbook is the intellectual output No. 3 in the framework of the LAWGEM project, which has to be realized from November 2020 to December 2021. Outlines of the chapters should be sent until 1st December, 2020. Final Drafts of chapters shall be submitted to Editors in Chief and Consortium Board until March 31st, 2021.

The research teams defined for the syllabi creation are the same groups which represent potential authors of the textbook. Particular chapters which are related to the referential syllabi will be written by the same working groups` members from the five LAWGEM partners. The obligation to create the syllabus and write the pertinent textbook chapter is incumbent on each particular working group. However, some members of the working groups can be more active in creating the syllabus, others in writing the pertinent textbook chapter, depending on the decision of each working group. But please note that each working group should form an authors' committee of three to five members, preferably from different LAWGEM partners. The authors' committee will write an initial draft to be discussed by the entire working group, before the final draft is submitted to the Editors in Chief and Consortium Board. In case of any problem in this regard, please contact the head coordinator.

The textbook should be used as the **main teaching material** and should give an overview of the different chapters and a more detailed explanation of the main parts of the relevant syllabus. Please avoid focusing on secondary topics. If necessary, the individual lecturers can prepare additional material for these topics which will not be included in the textbook. You are welcome to provide more detailed literature references. Please note that this textbook is also to be marketed commercially, so that it should appeal to a large number of readers. So please avoid project-specific statements.

THEORETICAL-METHODOLOGICAL CHALLENGES OF WRITING CHAPTERS

Chapters will be written with an aim to offer the basic gender-competent knowledge in the particular legal or non-legal field, e.g. the basic gender reconsideration of the particular discipline according to the syllabi of the LAWGEM curriculum. This means that each chapter needs to provide a comprehensive, systematic, convincing, informative and problem-oriented presentation of the most relevant topics and issues of the specific field but at the same time, each chapter needs to pursue the innovative and critical/deconstructivist approach which is required to overcome the traditional understandings and explanations of concepts, issues and phenomena in the particular field. It is essential to point out clearly how different our gender-competent approach is and why and in what sense contributes added value to the quality of legal knowledge. Please, go beyond the binary system of gender, meaning to include not only the female/male perspective but also the new approach of a "third" gender. Since the number of pages for each chapter is limited (max. 30 pages) please focus to give a comprehensive overview but avoid to include detailed explanation of sideline topics or make use of excurses many times, better use in this case references for further reading. Moreover, footnotes should be put to literature and jurisprudence you mention in your chapter.

Please send an outline of your chapter latest until 1. December 2020 to froehlich@europainstitut.de. The outline will be checked and you will get a feedback if it matches the instructions given here or if there are maybe some overlaps with other topics, so that we might avoid that you need to revise your work on a later stage.

CONTENT OF CHAPTERS – substantive and technical dimension

Each chapter must be written in accordance with the following basic structure required by the publisher (except for the Introduction, Conclusion and Practical Skills chapter):

- Introduction:
 - o importance,
 - o conceptual and/or legal framework
 - o and developments
- Main part:





- o explanation of different sub-topics according to the particular syllabus
- o examples of case law should mainly include International/European law; only if necessary should be included particular aspects of national legal order
- Conclusion:
 - o sum-up and future developments
- References

ADDITIONAL INSTRUCTION FOR THE CONTENT OF PARTICULAR CHAPTERS

In addition to the structure of the chapters, according to the publisher rules, we need to include specific components, set by Springer, to all chapters to be categorized as a textbook. These different components are explained in the Annex. There are mandatory and additional components. The following mandatory components need to be included in all chapters (except for introduction, conclusion), whereas the additional ones can be used, but only in addition to the mandatory components, not instead of them. Please find detailed information about each component in the annex.

AUTHORS OF CHAPTERS

Each chapter will be written collectively by 3 to 5 members of the working group (ideal would be 3) and the authors will be listed according to the alphabetical order of their surnames except the working group decides among themselves a different order. Each chapter should be reviewed by all members of the relevant working group and proof-read by an English native speaker before submission.

REVIEW

In addition to the review of the working group also the management board and the quality assurance board will give their review. Furthermore, the team of Saarland University will review all chapters to avoid overlaps and guarantee coherence and the above mentioned structure. Finally, Springer will ask an external expert to review the textbook before publishing.

TECHNICAL DETAILS RELATED TO THE LENGTH AND DESIGN OF CHAPTERS

Each chapter will have up to BUT NO MORE THAN 30 pages (1,5 to 2 authors` sheets per 30.000 characters, in total at most 45.000 to 60.000 characters).

Each chapter shall contain an abstract up to 200 words, and key words – 3 to 6.It will be written in
